My family suffered for many years; still my brother's suffering was far worse. I've grown to understand that now. It has taken a long time for me to reach this milestone. My work in public health has helped significantly.

When I stepped into the role of President Elect, my Health Director (Bill Smith) came right out and asked, "Is this (EDNCPHA) going to cause you to re-live everything". I responded with "No, I already re-live everything, everyday". Honestly, every single day of my life I wonder what I could have done differently. I'm confident there were times when I did all that I could; still there were times when I could have done more.

This year EDNCPHA has allowed me to make up for missed opportunities. I've worked with a group of passionate people in planning a conference filled with experts in their professions who can impart to each of us the knowledge, wisdom, and the courage to do more.

That's all I could have ever hoped to accomplish. I thank everyone who has worked tirelessly behind the scenes to bring this conference to fruition; and to all attendees, may you be reminded there is "a time for peace... I swear it's not too late."
