Future developments. The IRS has created a page on IRS.gov for information about Form W-9, at www.irs.gov/w9. Information about any future developments affecting Form W-9 (such as legislation enacted after we release it) will be posted on that page.

Purpose of Form

A person who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, payments made to you in settlement of payment card and third party network transactions, real estate transactions, mortgage interest you paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN to the person requesting it (the requester) and, when applicable, to:

 Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),

· An estate (other than a foreign estate), or

A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax under section 1446 on any foreign partners' share of effectively connected taxable income from such business. Further, in certain cases where a Form W-9 has not been received, the rules under section 1446 require a partnership to presume that a partner is a foreign person, and pay the section 1446 withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid section 1446 withholding on your share of partnership income.



For the first conference back AC (AFTER COVID-19), it was well attended in the Environmental Health Section. Program notes included a forward-thinking agenda about emergent issues and interests. Speakers represented innovations in septic tank manufacturer, recruitment and retention, how clandestine lab enforcement is changing, updates on the Children's Environmental Health Branch, and health equity in Environmental Health. The Section had a successful silent auction to raise funds for the scholarships and awards. The business meeting presented a new slate of officers, which includes Thomas Privott, Orange County, as President for 2022-2023; Laura Lerch, Durham County, as VP; Amanda Cabiness, Warren County, Treasurer; and Jennifer Edwards, Wake County, Secretary.
